

CPAWS Manitoba and FRCN Conservation Areas Initiative - Treasure Hunt Terms and Conditions

1. ABOUT

The Canadian Parks and Wilderness Society Manitoba Chapter (“**CPAWS Manitoba**”) and Fisher River Cree Nation Conservation Areas Initiative (“**FRCN Conservation Areas Initiative**”) are hosting a series of treasure hunts (the “**treasure hunt**”) in accordance with the Terms and Conditions contained herein, which all participants (the “**participant**”) shall agree to and accept as binding upon them. Participants will have the chance to win prizes as part of the contest portion (the “**contest**”).

2. ELIGIBILITY

The treasure hunt contests are open to residents of Manitoba. Participants must use the app TurfHunt and sign up using their name and email address or using the name and email address of a parent or caregiver.

3. ENTRY PERIOD

The three treasure hunts will remain open until March 31, 2022.

4. SUBMISSION CRITERIA

4.1. All participants must use the free TurfHunt app, which automatically tracks points. Please practise safe physical distancing and follow all [public health orders](#). CPAWS Manitoba is not responsible for entries that are lost, late, delayed, misdirected, unintelligible, illegible, incomplete, separated or undeliverable.

4.2. Participants must engage in only legal activities, taking into consideration safety and any local, municipal, provincial or federal law governing parks or protected areas where the photos are taken. All challenge entries, including photos, must show respect for the subject and the environment. Photos that were made while disturbing or damaging an animal or the environment are not permitted. On suspicion of illegal activity or disturbing or damaging nature, the participant will be excluded from entry into the contest.

5. PRIZES

To be considered in the treasure hunt contest, all participants must sign up using the TurfHunt app, which keeps track of participant names and scores.

5.1. Each month, we will draw a name at random from our pool of active players, who will then receive a \$25 Co-op gift card. Non-winning participants shall not be notified.

6. DISCLOSURE

6.1. In consideration of the permission to participate in the treasure hunt, participants agree to release and hold harmless CPAWS Manitoba and the FRCN Conservation Areas Initiative from any and all liability for personal injury, death, property damage or loss, or any other loss resulting from or arising out of participation in the event. Participation in the event includes,

but is not limited to, the risk of death or serious injury such as driving to/from various locations in Manitoba, or the conduct of other participants, including their negligence or willful misconduct.

- 6.2.** Participants certify that they will abide by all rules and regulations of the event. They further acknowledge that failure to abide by all safety rules and the direction of staff or volunteers may result in my being disqualified from participating in the event and forfeiting eligibility for event prizes. Participants also agree to release the event and its staff and volunteers from any and all liabilities, claims and causes of action, based on or arising from negligence or gross negligence on the part of its agents, volunteers and employees.
