

# Environmental Action Challenge

## Terms and Conditions

### 1. ABOUT

The Canadian Parks and Wilderness Society (“CPAWS”) and its Manitoba Chapter (“CPAWS Manitoba”) is hosting the ENVIRONMENTAL ACTION CHALLENGE (the “Contest”) in accordance with the Terms and Conditions contained herein, which all participants who enter the requested information (the “entry” or “entries”) into the Contest (the “participant” or “teacher” or “educator”) shall agree to and accept as binding upon them.

### 2. ELIGIBILITY

The Contest is open to educators and their classes, as well as youth groups (sports teams, or community organizations) in Manitoba. Only the educator/organizer who organizes the environmental action contest and completes this [Google form](#) shall be considered a participant with a valid entry.

### 3. ENTRY PERIOD

The entry period for participants runs from Dec 1 at 12 a.m. CT until May 31 at 11:59 p.m, for the spring package. And June 1 at 12 a.m. CT until Nov 30 at 11:59 p.m. CT, for the fall package. All entries must be received within this period. CPAWS Manitoba is not responsible for entries that are lost, late, delayed, misdirected, unintelligible, illegible, incomplete, separated or undeliverable.

### 4. SUBMISSION CRITERIA

**4.1.** Teachers/organizers can organize more than one entry if they teach multiple classes. There is no limit to the number of times the teacher enters as long as it is with different classes. If any students participate remotely, they can send photos to their teacher, who will submit them through our entry form. Each class/group must have a separate entry Form to be eligible for the random draw.

**4.2.** Complete this activity with your class, and fill out this [entry form](#).

**4.3.** To prove participation, the entry forms ask the teacher/organizer to submit photos of the activity. If there are identifiable people and you give us permission to use the photo for promotional purposes, you confirm that all identifiable people in the photos submitted for promotional purposes have provided their consent to the use of their likeness contained in the referenced images.

**4.4.** All photos proving participation must be of legal activities, considering safety and any local, municipal, provincial or federal law governing parks or protected areas where the photos are taken. All photos must show respect for the subject and the environment. On suspicion of disturbance or damaging nature, the teacher and their class will be excluded from entry into the Contest.

**4.5.** For a bonus entry, post about the great work your students did on social media with the hashtag #CPAWSactionplan, and tag or mention CPAWS Manitoba in your post. You can find us on [Facebook](#), [Twitter](#) and [Instagram](#).

## **5. PRIZES**

Regardless of whether a participant wins the Contest, all entries will be subject to section 6.1 of these Terms and Conditions.

**5.1.** All eligible entries will be entered into random draws to win one of three prizes, with winners notified within no more than 10 business days of the contest close date. Participants can win up to one prize each. Non-winning entries shall not be notified.

**5.2.** All decisions of the contest organizers are final.

**5.3.** Prizes: Four prizes will be awarded. The winners will be randomly selected. Each winner will receive a class doughnut party from Oh Doughnuts or treats from their local bakery.

**5.4.** Prior to receiving a prize, the winners will be required to sign an agreement ([entry form](#)) declaring that they agree to the rules and regulations.

## **6. PERMISSIONS AND RELEASE**

**6.1.** By entering the contest you agree to let CPAWS and CPAWS Manitoba publish your name, the name of your school or organization, the number of students who participated and any comments you supply on the entry form in a blog about the contest. This information may also be shared privately with funders.

**6.2.** Photos are required to participate in the contest. You may opt out of providing permission for photos to be used by ticking the box on the entry form.

**6.3.** If you do not use the [opt-out](#) button on the entry form you agree to let CPAWS and CPAWS Manitoba publish your submission of your action plan on our social media networks, blog and other publications and presentations (print or electronic or other media and/or otherwise publicly display all photos submitted). The teacher gives their consent to the organizer, for an indefinite period, unless otherwise advised, to display their name and comments about the contest along with the submitted photos.

**6.4.** By submitting the entry, the participant consents and agrees to these Terms and Conditions.
